

Tree Policy



This policy sets out South Ribble Borough Council's (SRBC) approach to the management of trees and woodlands on Council owned land. It is intended to act as a point of reference for the public, officers, elected members and professionals to ensure a clear, consistent and structured approach to the management of the borough's trees.

As a Council we recognise the importance of trees in combating air pollution through the sequestering of CO2 and other pollutants and the production of oxygen, we are committed to improving the air quality of our residents and will replace trees on a two planted for each one removed basis. Trees will be planted in line with "The Right Place, Right Tree" policy which will filter out trees that would otherwise grow too big for certain locations.

We have also committed to planting as minimum 110,000 new trees over the next four years, one for each of our residents.

1. Introduction

South Ribble Borough Council places a high value on our district wide tree cover and recognises that trees and woodlands are of vital importance in maintaining and improving the quality of life of those who live, visit and work in the borough. Trees are one of the most obvious natural assets, by virtue of their sheer size and prominence. It is our duty to ensure that future generations are able to enjoy the many benefits that our trees bring to the environment.

This policy is intended to act as a point of reference for members of the public, Councillors, officers and professionals to establish a clear and consistent approach to issues affecting trees on Council owned land or under the control of the Council.

Trees are a potential liability and SRBC has a duty of care to ensure that all of the trees on its land are kept in an acceptable condition and do not put persons and property at a level of risk which would be deemed unreasonable.

The local district is under the control of two different authorities – South Ribble Borough Council and Lancashire County Council. Each organisation has respective responsibilities in relation to the management of buildings, land, trees, open spaces and public highways. In relation to trees Lancashire County Council manage the majority of trees on and in the adopted highway, this policy does not apply to these trees.

2. Policy Aims

This policy has been designed to be as comprehensive as possible, however we acknowledge it does not cover every situation. The Council reserves the right to exercise discretion in application of this policy when to do so would be in the best interests of the Council.

The Council will manage its tree stock in accordance with good arboricultural practice and ensure that trees are inspected in accordance with the National Tree Safety Group guidance. (NTSG Common sense risk management of trees 2011).

The Council will only remove trees only when it is in accordance with good arboricultural practice, or as part of a management plan for the area and will look to increase its tree stock whenever possible.

The Council will ensure all tree work is carried out in accordance with BS;3998 2010 Tree Work – Recommendations. (BSI 2010).

Should you or your representatives wish to make a claim for damages against the council. <p>Tree touching a building</p> <p>A council owned tree touching private property.</p>	<p>If a tree in council ownership is touching your property, we will investigate and take action to remove the nuisance.</p> <p>Advice:</p> <p>In most cases the solution will be for the council to prune the tree, however in some cases it may be more appropriate to fell the tree. If pruning is appropriate, we will endeavour to stop the problem reoccurring within five years.</p> <p>You have a Common Law right to abate the nuisance associated with the trees encroaching on to your property. The following advice is given if you wish to exercise your Common Law right with respect to encroaching trees:</p> <p>a) You can only consider removing those parts of the tree from the point where they cross the boundary of your property. You have no legal right to cut or remove any part of a tree that does not overhanging your property;</p> <p>b) You are strongly advised to consult a professional tree surgeon for guidance on how best to prune back encroaching trees, unless the works are trivial meaning you could do the works with hand secateurs or similar;</p> <p>c) You are strongly advised to tell the owner of the trees what you plan to do. You can find out if the trees are owned by the council by contacting The Gateway;</p> <p>d) Before you consider doing any works to the trees you should find out if they are protected by a Tree Preservation Order or they are in a Conservation Area. If trees are protected, then you will need to gain consent by making an application / give notice to the council. For guidance on how to check if the trees are protected and how to make an application please contact: The Gateway;</p> <p>e) Legally you do not own those parts of the tree that encroach over your property and you should make arrangements to return these to the owner. You are advised to discuss this with your neighbour to agree a mutually acceptable solution. <p>Tree overhanging property</p> <p>Council tree encroaching onto private property.</p>	<p>We will not prune or fell a tree in council ownership to alleviate the nuisance of overhanging branches.</p> <p>Advice: The nuisance caused by overhanging branches may be considered as part of our general tree work programme and will be inspected accordingly, the programme is prioritised and subject to the resources available.</p> <p>If you wish to exercise your Common Law right to remove the nuisance associated with encroaching trees – see previous advice.</p>	<p>The enquiry will be answered within 12 working days of receipt and feedback provided to the customer. If the enquiry requires further research, we will indicate a timescale in the which the customer can expect to receive a full response.</p>
<p>Trees and Light</p> <p>Council tree restricting light in a private property.</p>	<p>We will not generally prune or fell council owned trees to improve natural light, however following a site inspection the council may thin the crown of the tree to allow natural light to reach other trees or vegetation.</p> <p>Advice: If natural light is being blocked by the growth of a hedge, then action may be taken to reduce the problem under the High Hedges Act Part 8 of the Antisocial Behaviour Act 2003. It is the responsibility of the homeowner to maintain their drains accordingly. <p>Trees, Leaves, Sap, Blossom & Fruit</p> <p>Council tree shedding leaves, sap, blossom or fruit over a private property.</p>	<p>We will not prune or fell a council owned tree to remove or reduce leaf fall or remove fallen leaves from private property.</p> <p>Advice: We will not prune or fell a council owned tree to remove or reduce the fall of leaves, sap, blossom or fruit or remove leaves, sap, blossom or fruit from private property, this is a natural part of the cycle and cannot be avoided. Honeydew is caused by greenfly feeding on the sap from leaves and excreting their sugary waste, this can be removed by washing with warm soapy water. <p>Trees & vandalism</p> <p>Any act of vandalism to a council owned tree.</p>	<p>We will investigate any reports of vandalism to a council owned tree and deal with accordingly.</p> <p>Advice: Generally, we plant larger trees which are less prone to vandalism, larger planting schemes are fenced initially to provide protection, this will be removed once they have become established. The Local Authority has powers to require a private individual to make safe a tree via the Local Government Miscellaneous Provisions Act 1976, this will only be used as a last resort.</p>

<p>Works to Council owned trees</p>	<p>The council intends to manage its trees, so they make a positive contribution to their locality and are reasonably safe and do not cause excessive nuisance.</p> <p>Advice: The council operates an in-house team who are responsible for the majority of council owned tree work throughout the borough. The team are professionally competent in all aspects of tree surgery and undertake tree work operations in accordance with British Standard 3998:2010 intended for use by arboriculturalists, tree surgeons and others involved with the maintenance of trees.</p> <p>On occasion the council will seek to employ contractors. These works may include stump-grinding, work to trees over the highway which require traffic management, out of hours emergency works, large scale works requiring specialist equipment, works exceeding a specific time frame in order not to impact on the current work schedule and tree works associated with the Councils Corporate Plan.</p> <p>Customer Enquiries</p> <p>The majority of non-emergency tree related enquires are received via The Gateway both via phone and e-mail, these are assessed against resources required, benefit and impact upon the tree.</p> <p>Once an appropriate officer is made aware, work determined to be classed as emergency works will</p>	<p>The enquiry will be answered within 12 working days of receipt and feedback provided to the customer. <p>Tree planting programme</p>	<p>The council is committed to maintaining and increasing the tree cover across the district, the council operates an annual tree planting programme. in addition, the council has committed to planting 110,000 trees across the borough over the next four years.</p> <p>Advice: When the decision is taken to remove a council owned tree, the Arboricultural Officer will determine whether it is appropriate to replant a tree in the same place or very close by, each tree removed will be replaced although this may be elsewhere in the borough. Aspects considered will be the impact of the tree on the site and future planting will take account the character of the site, its future use and local interests.</p> <p>The council will operate “The Right Tree, Right Place” policy which should prevent trees being planted in unsuitable locations.</p> <p>The council hold an annual “Tree Giveaway” event each year in which trees are gifted to local residents to plant in their own gardens.</p> <p>Donated Trees</p> <p>The council is currently revamping the Arboretum on Worden Park and residents are encouraged to sponsor these trees.</p>	<p>The enquiry will be answered within 12 working days of receipt and feedback provided to the customer.
